## **By Laws Update**

#### Article V

Mission Statement

The National Association of Catholic Nurses, USA (NACN-USA) emboldens the ministry of Catholic Nursing and upholds the moral principles of the Magisterium of the Catholic Church. Through prayer, leadership, fellowship, and the formation of conscience, we strive to imitate Jesus Christ and His teachings. Our members endorse the dignity and sanctity of all human life from conception to natural death. We invoke the Holy Spirit and seek the protection of Our Lady of the Immaculate Conception.

#### Article 17

**Section 2-** Councils (new additions)

## 6. Fees/Annual Dues

- a. All Council members are required to pay an annual fee according to NACN USA structure for licensed nurses, retired nurses, and associate members.
- b. All School-based Council members are to be members of NACN-USA.
- c. School-based pre-licensed Council members pay an annual discounted student fee

Motion by Maria that the new #6 under Councils, Section 2 regarding fees and annual dues be accepted.

## 7. Scope of NACN USA Council Members
